## 2016 / 2017 ROADSIDE MOWING CONTRACT Reference Contract # 16-22

J. Jablonski and Sons, Inc. agrees to provide services for roadside mowing on primary blacktop roads, for contract years 2016 and 2017. **NOTE** – this includes the first of four possible one-year renewal options per 2016 contract specifications. Subsequent renewals will be evaluated on a yearly basis beginning in 2018.

First mowing will not begin prior to June 15<sup>th</sup> and will be completed by July 4<sup>th</sup> per both proposals.  
Second mowing to be mutually agreed upon by ICRC and J. Jablonski and Sons Inc.

**Proposal B is selected for 1<sup>st</sup> mowing of 2016.** Conditions will be evaluated and subsequent mowing proposals will be determined at a later date for the remainder of 2016 and all of 2017.

**INDEMNIFICATION:** Contractor agrees to hold harmless and indemnify the Ionia County Road Commission, its commissioners, officers, agents and employees, from any and all claims, suits and judgments to which the commission, its commissioners or employees may be subject and for all costs and actual attorney fees which may be incurred arising out of any injury to persons or damage to property, including property of the commission, whether due to negligence of the contractor or the joint negligence of the contractor and the commission, arising out of the work specified in this proposal, or in connection with work not authorized in this proposal, or resulting from failure to comply with the terms of this proposal. Contractor will not be obligated to indemnify the Ionia County Road Commission for any injury or property damage arising out of the sole negligence of the Ionia County Road Commission, its commissioners, officers, agents or employees.
